

SCRUTINIZER'S REPORT ON REMOTE E-VOTING FOR AMRIT AGRO INDUSTRIES LIMITED

32nd Annual General Meeting of the Members of Amrit Agro Industries Limited held on Friday, the 14th September, 2018 at 02.30 P. M. at Chaudhary Bhawan (Near Jain Mandir), E- Block, Kavi Nagar, Ghaziabad (U. P.) -201 002.

Subject: Passing of resolutions through electronic voting pursuant to section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Amendment Rules, 2015.

Dear Sir,

- Pursuant to the resolution passed by the Board of Directors of Amrit Agro Industries Limited (hereinafter referred to as **the "Company"**) on 2nd August, 2018, I have been appointed as a Scrutinizer for the remote e-voting process as mentioned under Rule 20(4)(ix) of the Companies (Management and Administration) Amendment Rules, 2015.
- 2. The Company engaged National Securities Depository Limited ("NSDL") as the Service Provider for extending the facility of electronic voting to the shareholders of the Company. The Service Provider provided a system for recording the votes of the Shareholders electronically on all the items of business sought to be transacted in the 32nd Annual General Meeting ("AGM") of the Company, which was held on Friday, the 14th September, 2018. National Securities Depository Limited ("NSDL") had set up e-voting facility on their website, https://www.evoting.nsdl.com. The Company had uploaded all the items of the business to be transacted on the website of the Company and also it's Service Provider to facilitate their shareholders to cast their vote through e-voting.
- 3. As on the cutoff date for despatch of notice of annual general meeting there were 2864 Shareholders of the Company. The Notice of Annual General Meeting and Circular for e-voting was sent in physical mode to all the shareholders.

- 4. The Notice sent to shareholders contained the detailed procedure to be followed by the shareholders who were desirous of casting their votes electronically as provided in the Rule 20(4)(iii)(A) to (C) of the Companies (Management and Administration) Amendment Rules, 2015.
- 5. The cutoff date (Record date) for the purposes of identifying the Shareholders who will be entitled to vote on the resolutions placed for the approval of the shareholders was 07.09.2018. The e-voting facility was kept open from 11th September, 2018 (9.00 A.M.) to 13th September, 2018 (5.00 P.M.).
- 6. Pursuant to Rule 20(3)(v) of Companies (Management and Administration) Amendment Rules, 2015, the Company also released an advertisement, which was published more than 21 days in advance from the date of beginning of voting period in Financial Express, English Newspaper and in Jansatta, Hindi Newspaper both dated 22nd August, 2018. The notice published in the newspaper carried the required information as specified in the Rule 20(4)(v) (a) to (h) of the Companies (Management and Administration) Amendment Rules, 2015.
- 7. At the end of the voting period on September 13, 2018 at 5.00 P.M. the voting Portal of the service provider was blocked forthwith. On September 14, 2018 after the annual general meeting the votes cast through e-voting facility was duly unblocked by me as a Scrutinizer in the presence of Mr. Satish Jha and Mr. Ashok Kumar who acted as the witnesses, as prescribed in sub rule 4 (xii) of said Rule 20 of Companies (Management and Administration) Amendment Rules, 2015.
- 8. Particulars of all Votes cast by electronic mode have been entered in the register separately maintained for the purpose in electronic mode.

As a Scrutinizer the report of the e-voting carried by the shareholders was duly complied, the detail of which are as follows:-
